WHEREAS, Supervisor Taylor decided to devote his talents to the County of San Diego by accepting appointment as a Fifth District Supervisor in August of 1973; and

WHEREAS, Supervisor Taylor was elected to his office as Fifth District Supervisor in November of 1974; and

WHEREAS, Supervisor Taylor served as Chairman of the Board of Supervisors from 1975 to 1976; and

WHEREAS, Supervisor Taylor has participated in many civic activities and performed his legislative duties in a most admirable manner; and

WHEREAS, Supervisor Taylor has decided not to stand for reelection having devoted many years to public interest activities in addition to those five years in the legislative service for the County; and
