BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of DIGITAL DATA SYSTEMS, INC. is hereby accepted and the City Manager is hereby authorized to execute a contract for the following:

1. A contract with DIGITAL DATA SYSTEMS, INC. for Lease of WORD PROCESSING EQUIPMENT for a period of one (1) year beginning approximately December 1, 1978 through November 30, 1979 at a monthly lease cost of \$3,580.50; terms net 10 days, with an option to renew for four (4) additional one (1) year periods; and accepting assignment of this contract by DIGITAL DATA SYSTEMS, INC. to BANK OF AMERICA.
2. Authorizing a joint contract with DIGITAL DATA SYSTEMS, INC. and DIGITAL EQUIPMENT CORP. for Maintenance of WORD PROCESSING EQUIPMENT for a period of one (1) year beginning approximately December 1, 1978 through November 30, 1979 at a monthly cost of \$1,396.00 per month; terms net 10 days plus sales tax, with an option to renew for four (4) additional one (1) year periods at a cost not to exceed DIGITAL EQUIPMENT CORP'S. published maintenance price list.
