

RESOLUTION No. 222251 (R. 79-841)


Adopted on NOV 20 1978

That the acceptance by the City Manager of that street easement deed of FUTURE 10 LTD, a limited partnership, executed in favor of The City of San Diego, bearing date of July 14, 1978, conveying to said City the permanent easement and right of way for a public street and incidents thereto, over, under, upon, along and across all that portion of Lot A 91 of San Ysidro, Map No. 1174, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named CYPRESS DRIVE.

That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution attested by him under seal, to be recorded in the office of the San Diego County Recorder.
