WHEREAS, the San Diego Regional Criminal Justice Planning Board was formed pursuant to supporting resolutions adopted by the County of San Diego and the incorporated cities within San Diego County; and

WHEREAS, Resolution No. 216456 was adopted on July 21, 1976; and

WHEREAS, the bylaws adopted by the Planning Board to regulate its affairs were recently amended to add a membership position for a municipal court judge from an outlying municipal court judicial district and to replace the County's Assistant Chief Administrative Officer, Fiscal and Justice Agency, with a Chief Administrative Officer of the County of San Diego because of the County's recent administrative restructuring; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that paragraph 2 of Resolution No. 216456 is hereby amended to reflect a change of membership of the San Diego Regional Criminal Justice Planning Board to include an additional municipal court judge and to replace the County's Assistant Chief Administrative Officer, Fiscal and Justice Agency, with the Chief Administrative Officer of the County of San Diego.
