WHEREAS, the Planning Department has submitted the above mentioned document to the City Council Rules Committee for consideration, and the Rules Committee has reviewed this material and found it appropriate with respect to implementing the Coastal Act; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Council formally approve the submission to the coastal commissions of the Centre City-Pacific Highway Corridor Issue Identification Report, on file in the office of the City Clerk as Document No. 765001.
