VACATION OF BALBOA AVENUE BETWEEN OLNEY STREET
AND THE ALLEY IN BLOCK 211 OF MAP 854 AND
MAP 791

NOV 20 1978

WHEREAS, it is proposed that Balboa Avenue between Olney Street and the Alley in Block 211 of Map 854 and Map 791 be vacated; and

WHEREAS, there is no present or prospective use for the street either for the public street system for which the right-of-way was originally acquired or for any other public use of a like nature that can be anticipated in that the right of way is not needed for public street purposes, a bikeway, or for access to open space; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation or abandonment is not inconsistent with the General Plan or an approved Community Plan; and

WHEREAS, the public street system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, California, that Balboa Avenue between Olney Street and the Alley in Block 211 of Map 854 and Map 791, as more particularly referred to in Resolution of Intention No.

222036, is unnecessary for present or prospective

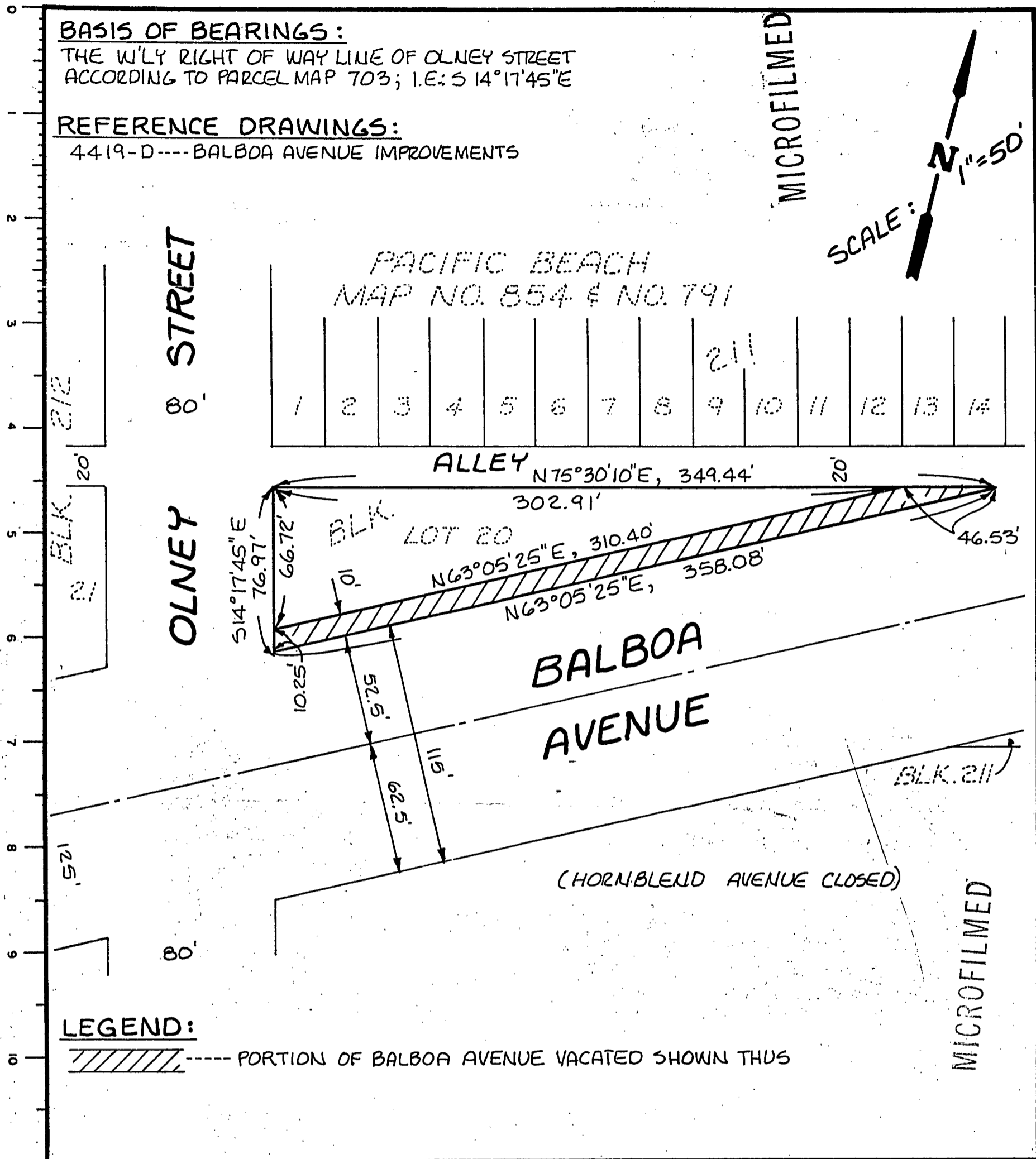
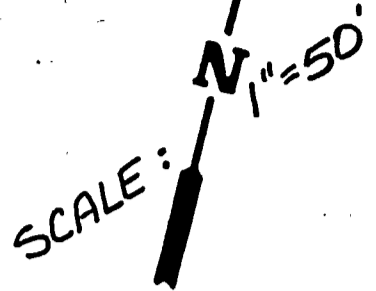
