APPROVING MAP OF ELDORADO HILLS UNIT NO. 1 AND
ACKNOWLEDGING RECEIPT OF SUBDIVIDER'S ASSURANCE
OF COMPLIANCE WITH THE AFFIRMATIVE MARKETING
PROGRAM.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by
JOHN M. LEACH, a Registered Civil Engineer, entitled "ELDORADO
HILLS UNIT NO. 1 Being a subdivision of a portion of Lot 60,
Rancho Mission of San Diego, California, according to the partition
map thereof, made in Superior Court Case No. 348 and filed in the
office of County Recorder of San Diego County as Map No. 330, and
portions of Lots 'C,' 'D' and 'E,' Referee's Partition Map of a
portion of Lot 70, Rancho Mission of San Diego filed in Superior
Court Case No. 15191, in the City of San Diego, County of San
Diego, State of California.", is made in the manner and form
prescribed by law and conforms to the surrounding surveys; that
said map and the subdivision of land shown thereon is hereby
approved and accepted; and said Council hereby accepts on behalf
of the public, the following: Colina Dorada Drive, Invierno
Court and Madrugada Court for public purposes; and said streets
are hereby declared to be public streets and dedicated to the
public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts
on behalf of The City of San Diego, a municipal corporation, the
easement for open space over Lot 16, together with the easements
with the right of ingress and egress for the construction
and maintenance of drainage facilities, all as granted and
shown on this map within this subdivision.



BE IT FURTHER RESOLVED, that said Council hereby acknowledges receipt of assurance from the subdivider SHAPELL-LOMASANTAS PARTNERSHIP, that said subdivider will comply with the Affirmative Marketing Program as outlined in Document No. 757438, on file in the office of the City Clerk, and in reliance on said assurance does hereby accept the final map of ELDORADO HILLS UNIT NO. 1.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
