

RESOLUTION No. 222269 (R-79-928)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement, drainage easement and slope easement deed executed in favor of the City of San Diego, bearing date of April 27, 1978, conveying to said City the easements for drainage, slope and public street purposes across those portions of Lot 70, Rancho Mission of San Diego, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed as Parcel J, is hereby dedicated as and for the public street and the same is hereby named CALLE DE VIDA and the land therein conveyed as Parcel K is hereby dedicated as and for a public street, and the same is hereby named COLINA DORADA DRIVE.

That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution attested by him under seal, to be recorded in the office of the San Diego County Recorder.
