

RESOLUTION No. 222271 (R- 79-930)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that slope and street easement deed of the United States of America, bearing date of April 17, 1978, conveying to said City easements for slope and public street purposes across all those portions of Lot 70, Rancho Mission of San Diego, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed as Parcels A, B and C is hereby dedicated as and for public street purposes and Parcels A and B are hereby named CALLE DE VIDA and the land conveyed as Parcel C is hereby named COLINA DORADA DRIVE.

That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution attested by him under seal, to be recorded in the office of the San Diego County Recorder.
