LILL, a Registered Civil Engineer, entitled "ELDORADO HILLS UNIT NO. 3 Being a subdivision of portions of Lots 'C,' 'D' and 'E,' Referee's partition map of a portion of Lot 70, Rancho Mission of San Diego filed in Superior Court Case No. 15191, in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Petirrojo Court, Papagallo Court and Joyas Court for public purposes; and said streets are hereby declared to be public streets and dedicated to the public use.
