BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Auditor is hereby authorized to establish a Balboa Park Facilities Fund No. 10501, wherein all proceeds of settlement of fire damage to Old Globe Theatre (\$123,522.25) and the Electric Building (\$750,000) shall be deposited.

BE IT FURTHER RESOLVED, that such moneys shall be used for the improvement of Balboa Park Buildings and such other costs that are appropriate thereto.

BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with ATKINSON, JOHNSON AND SPURRIER, INC., Engineers, to determine the extent of present life hazards and to provide remedial recommendations and their cost estimates for the following Balboa Park buildings:


1. Municipal Gym

3. Palisades Building
4. House of Charm
5. El Centro Cultural De La Raza
6. Conference Building;
