VACATION OF A PORTION OF THE ALLEY WITHIN  
CLAIREMONT UNIT NO. 7, MAP NO. 2872

WHEREAS, it is proposed that a portion of the alley within Clairemont Unit NO. 7, Map No. 2872 be vacated; and

WHEREAS, there is no present or prospective use for the alley either for the public street system for which the right-of-way was originally acquired or for any other public use of a like nature that can be anticipated in that the alley is not needed for access to adjacent property or for circulation within the area; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation or abandonment is not inconsistent with the General Plan or an approved Community Plan; and

WHEREAS, the public street system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, California, that a portion of the alley within Clairemont Unit No. 7, Map No. 2872, as more particularly referred to in Resolution of Intention No. 222116, is unnecessary for present or prospective public street purposes.


BE IT FURTHER RESOLVED, that a portion of the alley within Clairemont Unit No. 7, Map No. 2872, as more particularly

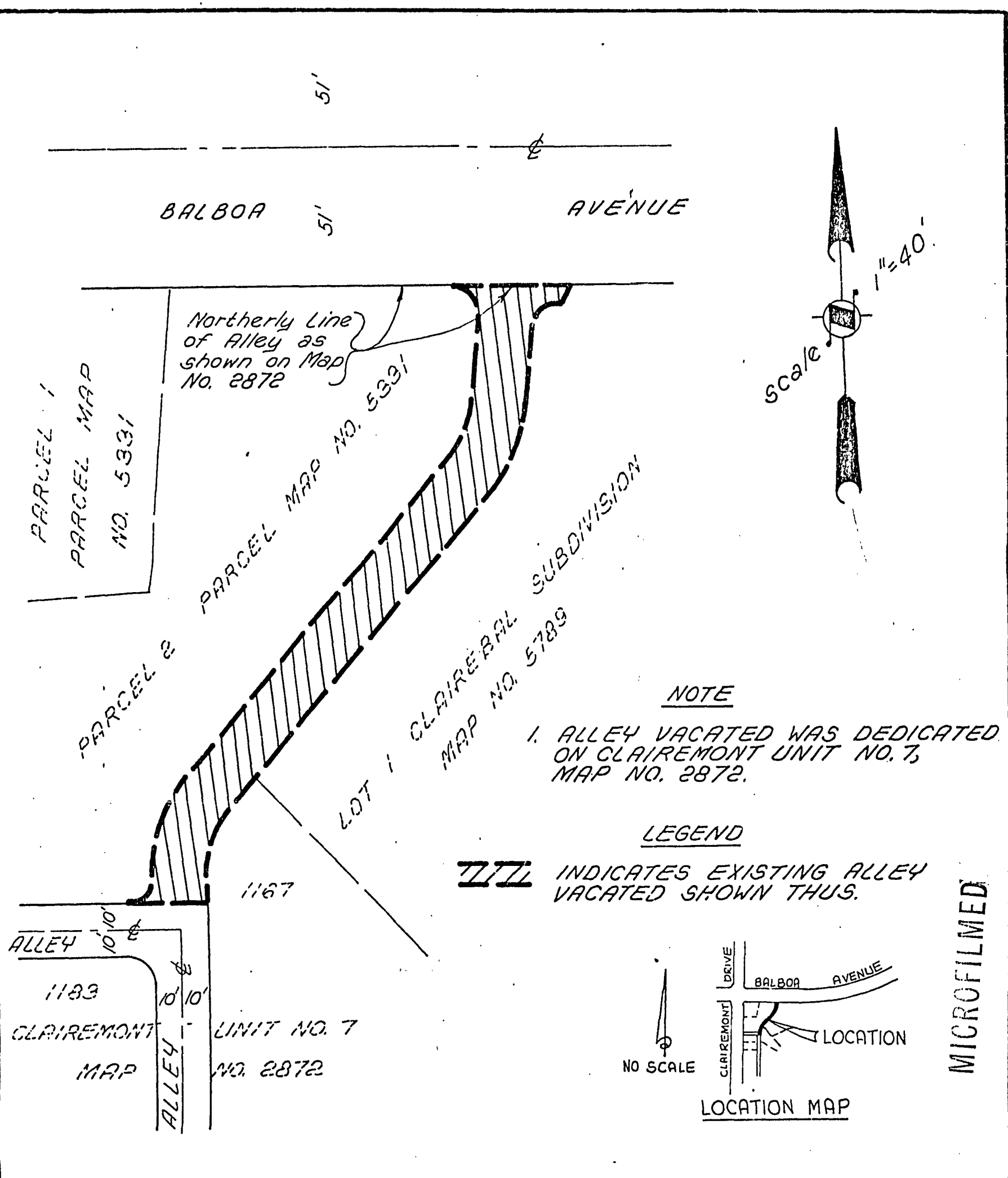
