Donald R. Jordan	Park and Recreation	\$95	Mr. Jordan is an Equipment Operator I in the Parks Division. He suggested that trash cans be identified with stickers rather than painting them. Estimated annual savings are \$1,936. This is a partial award pending a final 12-month review.
Robert D. Peters	Engineering and Development	\$85	Mr. Peters is a Senior Engineering Aide. He suggested that E&D requirement letters be sent to the Building Inspection Department for dispersal to applicants to eliminate delays in processing. Estimated annual savings are \$838.
Dennis M. Grady German Gonzalez	Personnel	\$60	Both Mr. Grady and Mr. Gonzalez are Associate Personnel Analysts. They suggested that the backs of job announcements be pre-printed. Estimated annual savings are \$1,237. This is a partial award pending a final 12-month review.
Mary E. Walker	Fire	\$50	Ms. Walker is an Intermediate Typist. She suggested that the internal maintenance of payroll sheets be eliminated. Estimated annual savings are \$1,021. This is a partial award pending a final 12-month review.
