WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Bruce L. Freeman	General Services	\$50	Mr. Freeman is a Machinist Supervisor in the Equipment Division. He suggested that anti-litter nets be used to cover material transported in open bed trucks. This saves an estimated \$1,000 annually in the purchase of tarpaulins. This is a partial award pending a final 12-month review.
Herbert M. Yaklin	Park and Recreation	\$30	Mr. Yaklin is a Utility Worker I in the Park Division. He suggested a safety modification to the front reel lift control levers of Turfking mowers. This was felt to be a significant safety improvement.
Thomas C. Feldscher	Fire	\$30	Mr. Feldscher is a Fire Fighter. He suggested that a new type of goggle be used for eye protection. Not only does this goggle have a higher safety rating, it is also less expensive than the goggle it replaces.
Gloria L. Gordon	Police	\$25	Ms. Gordon is an Intermediate Typist. She suggested that an automated information system be used to identify owners of stolen bicycles. The use of the system is expected to return a higher percent of stolen bikes to their original owners.
