Kevin C. Dubler	Fire	\$25	Mr. Dubler is a Fire Fighter. He suggested that flash arrestors be purchased for all oxygen/acetylene cutting torches. This was felt to be a significant safety improvement.
Gail F. Jeromin	Planning	\$20	Ms. Jeromin is a Zoning Representative. She suggested that Inspection Notice form letters be pre-printed. Estimated annual savings are \$343. This is a partial award pending a final 12-month review.
Linda L. Smith	Risk Management	\$10	Ms. Smith is an Intermediate Typist. One year ago she earned a \$10 award for her idea to send each new employee an introductory letter to the Suggestion Awards Program. Participation has increased so drastically that another award is merited.
George R. Ikeda	General Services	\$10	Mr. Ikeda is a Carpenter in the Buildings Division. He suggested that three different dimension blocks used in setting lawn mower blades be made into one block. Estimated savings are \$100 annually.
