Timothy L. O'Rourke	Fire	\$10	Mr. O'Rourke is a Captain. He suggested that parking curbs be installed at Fire Station 10 to eliminate the damage done to lawn areas. This was felt to be a significant improvement.
Larry A. Moratto	Police	\$10	Mr. Moratto is a Police Officer. He suggested that size of the field note book be increased. This was felt to be a significant improvement.
Herbert M. Yaklin	Park and Recreation	\$10	Mr. Yaklin is a Utility Worker I in the Park Division. He suggested that standard hand signals be used to direct drivers when backing. This was felt to be a significant safety improvement.
James Von Rummelhoff	Police	\$10	Mr. Von Rummelhoff is an Evidence Technician. He suggested that the laminating machine be relocated. This saves approximately \$100 annually in travel time.
