Thomas B. Wells	General Services	\$10	Mr. Wells is a Carpenter in the Buildings Division. He suggested that back-up alarms be installed on trucks used at City facilities with heavy public usage. Although installation will require supervisory control, this is considered to be a significant safety improvement.
