APPROVING MAP OF LA JOLLA FARMS, LOT 46, REVISED.

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by M. L. SPLITSTONE, a Registered Civil Engineer, entitled "LA JOLLA FARMS, LOT 46, REVISED Being a subdivision of Lot 46 of La Jolla Farms according to Map thereof No. 3487, and a portion of Pueblo Lot 1311 of the Pueblo Lands of San Diego according to Map thereof made by James Pascoe in 1870, a copy of which said map was filed in the office of the County Recorder of San Diego County, November 14, 1921, as Miscellaneous Map No. 36, all in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements for pedestrian and non-motor vehicular use as granted and shown on said map and subject to the conditions set forth thereon.


