That the CREST CANYON INTERIM EROSION CONTROL PLAN be and it is hereby approved.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to do by City forces all the work described in the Manager's Report of December 4, 1978, "Crest Canyon--Interim Erosion Control Plan"; this plan would place rock revetments within the area of the gorge to stabilize further erosion and decrease the amount of silt being deposited in the San Dieguito Lagoon area in the City of San Diego, California, pursuant to said recommendation of the City Manager.
