

**RESOLUTION No.** 222314 (R-79-904)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that Street Easement Deed of DINO POLSELLI and ELIZABETH C. POLSELLI, executed in favor of The City of San Diego, bearing date of October 26, 1978, conveying to said City a permanent easement and right of way for a public street, and incidents thereto, over, under, upon, along and across all that portion of Lot 10, in Block 7 of Sunnyslope Addition to Encanto Heights, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street, and the same is hereby named MADERA STREET; and the land therein conveyed as Parcel 2 is hereby dedicated as and for a public street, and the same is hereby named 69TH STREET.

That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution attested by him under seal, to be recorded in the office of the San Diego County Recorder.
