RESOLUTION NO. 222327

WHEREAS, the Federal Aid Urban (FAU) Advisory Committee for the San Diego Region has requested all jurisdictions to adopt resolutions supporting legislation to legalize the exchange of FAU funds with State Gas Tax revenues; and

WHEREAS, such an exchange would benefit the City of San Diego area by reducing the "red tape" associated with FAU projects; and

WHEREAS, elimination of current State and Federal reviews and unnecessary requirements would speed up project construction and thus make construction dollars go further during these inflationary times; NOW, THEREFORE,

BE IT RESOLVED, that The City of San Diego supports the concept of reducing "red tape" associated with Federal programs.

BE IT FURTHER RESOLVED, that the City supports legislation that would allow the exchange of FAU funds with State Gas Tax funds.
