WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Rodger A. Blakey	General Services	\$625	Mr. Blakey was a Sign Painter at the time of his suggestion. He suggested that large overhead signs be repainted rather than buying new signs. Actual first year savings of this idea is \$6,250.
Eldon D. Smith	Police	\$500	Mr. Smith is a Sergeant. He suggested that School Safety Patrol Officers be allowed to accumulate a maximum of 80 hours of compensatory time. This is expected to save the City \$13,117 annually in overtime payment. This is a partial award pending a final 12-month review.
William C. Pontsler	General Services	\$400	Mr. Pontsler is an Electrical Supervisor in the Buildings Division. He suggested that the City use "watt miser" type fluorescent lamps. Savings are expected to be \$10,200 annually. This is a partial award pending a final 12-month review.
James N. Burgess Andrew Chavez William R. Cotton	Water Utilities	\$380	One year ago these suggesters earned a \$450 award for their idea to revise the compound water meter testing and calibration procedure. One year's experience has identified an additional savings of \$3,786.
