Harry F. Haas	Police	\$190	Mr. Haas is a Police Officer. He suggested that the City establish a fee for the processing of each application for the operation of a taxicab, automobile-for-hire, and sightseeing vehicle business. Estimated savings of this idea are \$3,750 annually. This is a partial award pending a final 12-month review.
Valérie S. Smith	Risk Management	\$190	Ms. Smith is an Intermediate Typist. She suggested that an information stamp be used for easy access of the information contained in claims recovery cases. Estimated annual savings are \$3,683. This is a partial award pending a final 12-month review.
Derrel L. Goodner	Police	\$135	Mr. Goodner is a Police Officer. He suggested that two forms used in the Pawn Detail teletype system be eliminated. Estimated savings are \$2,718. This is a partial award pending a final 12-month review.
Daniel Karsh	Police	\$110	Mr. Karsh is a Sergeant. He suggested that dispatch metering devices be read hourly rather than every half-hour. Savings are estimated at \$2,221 annually. This is a partial award pending a final 12-month review.
