WHEREAS, the Council of The City of San Diego authorized by Resolution No. 130049 dated December 5, 1955, execution of an agreement with the State of California to include eligible employees under Social Security coverage; and

WHEREAS, The City of San Diego executed an agreement with the State of California, State Employees Retirement System Board of Administration, on December 9, 1955, providing for the inclusion of eligible employees of said City in the California State Social Security Agreement of March 9, 1951, a copy of said agreement on file in the Office of the City Clerk as Document No. 727184; and


WHEREAS, such coverage was authorized pursuant to Section 218 of the Social Security Act; and

WHEREAS, Section 7 of said agreement provides that the City shall have the right to terminate such participation and coverage upon giving at least two years advance notice in writing to the State, effective at the end of the calendar year specified in the notice; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby fully authorized and empowered to give notice to the State of California of intended withdrawal from said Social Security System, pursuant to the provisions of Section 7 of that certain agreement on file in the Office of the City Clerk as Document No. 727184.
