(R. 79-1005)

WHEREAS, the City Council has in Resolution No. 221970 declared that certain weeds, rubbish, refuse and dirt existing on private property more particularly described in said resolution constitute a public nuisance; and

WHEREAS, the Council has in said resolution declared its intention to order the abatement of same; and

WHEREAS, the hearings provided for in said resolution and required by law have been held and all objections to the proposed removal of weeds, rubbish, refuse and dirt have been fully heard and considered; and

WHEREAS, the Council has in Resolution No. 222343 overruled and denied any and all objections made except for those, if any, more particularly described in Exhibit A attached hereto and incorporated herein which were allowed; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Solid Waste Superintendent of The City of San Diego, the person previously designated as the Superintendent in this matter, is hereby ordered to abate said nuisance by having the weeds, rubbish, refuse and dirt removed.
