
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City and the San Diego Transit Corporation, a Capital Grant contract with the URBAN MASS TRANSPORTATION ADMINISTRATION (UMTA) in the amount of \$795,528.00 for the purchase of buses, support vehicles and related equipment and office furniture for Project No. CA-03-0162, under the terms and conditions set forth in the grant contract on file in the office of the City Clerk as Document No. 765175.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer the sum of \$10,667.00 from Public Transportation Reserve Fund 2571 to Transit System Purchase 7 Buses Fund 38015, to cover the 1 1/2% sales tax not eligible for Federal participation.
