

RESOLUTION NO. 222347

WHEREAS, CALTRANS has proposed to add portions of North Harbor Drive, Nimitz Boulevard, Grape Street and Hawthorn Street to the State Highway System and to delete State Highway 209 and, pursuant to Section 256.1 of the Streets & Highways Code, set a public hearing thereon for Wednesday, December 6, 1978; and

WHEREAS, the City Manager by report No. 78-228 dated December 1, 1978 has recommended that the aforesaid addition be approved, but that the deletion be opposed; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. The addition of a new route to the State Highway System connecting the terminus of Interstate 8 at Sunset Cliffs Boulevard to Interstate 5 via Nimitz Boulevard, North Harbor Drive and the Grape/Hawthorn Street one-way couplet be and the same is hereby approved.

2. The proposed deletion of State Route 209 from the State Highway System be and the same is hereby opposed.

3. The reasons for the position of The City of San Diego are as more particularly set forth in report No. 78-228 from the City Manager dated December 1, 1978.
