TIMMINS CONSTRUCTION INC., a corporation, for the CONSTRUCTION OF FIRE STATION #29 IMPROVEMENTS, Base Bid with Additive Alternate No. 1, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the Office of the City Clerk as Document No. 752236.
- 2. That the expenditure of \$176,000 out of Third Year Block Grant Fund 2930, and \$57,444 out of Fourth Year Community Block Grant Fund Contingencies, and \$19,838 out of Capital Outlay Fund 245 of the City of San Diego are hereby authorized solely and exclusively for providing funds for said project and related costs.
- 3. That the City Auditor be authorized to transfer \$57,444 out of 73.95 Fourth Year Community Block Grant Fund Contingencies to 73.56 Fire Station 29.
