WINTON, JR., a Registered Civil Engineer, entitled "HALEMAKAI Being a subdivision of a portion of the north half of the Southeast Quarter of Pueblo Lot 212 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to Map thereof made by James Pascoe in 1870, a certified copy filed in the office of the County Recorder of San Diego County as Miscellaneous Map No. 36, together with a portion of Lot "B" of Loma Alta No. 2, according to Map thereof No. 1082, filed in the office of the County Recorder of San Diego County.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.
