RESOLUTION NO. 222370 (R.79-944)

WHEREAS, The City of San Diego is the owner of an easement for waterline purposes affecting that portion of Pueblo Lot 1109 of the Pueblo Lands of San Diego; and

WHEREAS, the Property Department has requested that the City quitclaim to CONROCK COMPANY, its interest in and to said easement; and

WHEREAS, the owner of the property wishes to clear title to his property; and

WHEREAS, the herein described property is surplus to City needs and has never been used for the purpose for which it was acquired; and

WHEREAS, this action is exempt from the provisions of the California Environmental Quality Act of 1970 under City guidelines for implementation of said Act, as amended; and NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That that certain real property right described in that quitclaim deed on file in the office of the City Clerk as Document No. 765201, be, and the same is hereby vacated and abandoned.


