


RESOLUTION NO. 222374 (R.79-982) DEC 11 1978

BE IT RESOLVED, that the acceptance of the City Manager of those street easement deeds of ROBERT and LILLIAN WILCOX, PLUM and RICHARD MORAN, JOSEPH and MARY RIZZO, SAMUEL and ETHEL LUNDGREN, PEARL and SEYMOUR OSTROW and RALPH and YETTA GOLDVARG, executed in favor of The City of San Diego, bearing dates of August 15, 1978, August 14, 1978, August 16, 1978, August 16, 1978, August 10, 1978 and August 14, 1978 respectively, conveying to said City the permanent easement and right-of-way for a public street and incidents thereto, over, under, upon, along and across all that portion of the Southwest Quarter of Section 32, Township 14 South, Range 2 West, San Bernardino Meridian, as more particularly described in said deeds, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named TREENA STREET.

That the City Clerk is hereby authorized and directed to deliver said deeds and a certified copy of this resolution attested by him under seal, to be recorded in the office of the San Diego County Recorder.

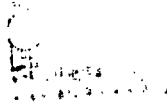
