

RESOLUTION NO. 222377

DEC 11 1978

WHEREAS, Ordinance No. 12424 adopted August 28, 1978, establishes minimum operating requirements for peep show establishments and authorizes the City Manager or his delegate to inspect said establishments in order to ensure compliance with applicable regulations; and

WHEREAS, it is necessary to establish a fee to defray the cost of inspecting peep show establishments by City staff; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that a semiannual fee of one hundred and fifty dollars (\$150), payable to the City Treasurer, prior to the time of license issuance or renewal, shall be established to defray the cost of twenty-five dollars (\$25) per inspection for each of six inspections of peep show establishments during each license period.

BE IT FURTHER RESOLVED, that where appropriate and necessary, the City Manager is authorized to revise the inspection fee for peep show establishments and all said fee schedules or subsequent revisions shall be filed and maintained in the City Clerk's office in a rate book of City fees and charges.
