

RESOLUTION NO. 222381

DEC 11 1978

WHEREAS, the Political Reform Act of 1974 was amended by Assembly Bill 3257 to provide that persons appointed or nominated to certain public offices file statements of economic interest not more than 10 days after assuming office rather than 10 days before which was the prior requirement (Government Code Sections 87202 and 87302); and

WHEREAS, said amendment is effective January 1, 1979; and

WHEREAS, the various Conflict of Interest Codes of the departments, boards and commissions of the City should likewise be amended to reflect this change pursuant to Section 87306 of the Government Code; and

WHEREAS, normally said amendment should be submitted by each department, board or commission to the Council as the code reviewing body for approval; and

WHEREAS, said change is the same for all codes and the Council desires to approve the change for all codes in one action in order to avoid the need for the many separate administrative acts by the various departments, boards and commissions; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. Amendment of all of the Conflict of Interest Codes of the departments, boards and commissions of The City of San Diego to provide that new employees appointed, promoted or

transferred to designated positions shall file statements of financial interest not more than ten days after assuming office (or if subject to confirmation, ten days after being confirmed) be and the same is hereby approved.

2. The City Clerk is hereby directed to attach a copy of this resolution to each code heretofore approved and also to forward a copy thereof to each City agency.
