

RESOLUTION NO. 222386 (R.79-1000)

WHEREAS, the City Council on April 10, 1978, in connection with the proposed acquisition of land necessary for MONTGOMERY WALLER NEIGHBORHOOD PARK #5, continued said item for three (3) months "until such time as the Council has reviewed and adopted new neighborhood park standards", and

WHEREAS, in connection with said continuance, the Council declared a "moratorium" on further acquisitions of neighborhood parks identified in the Capital Improvement Program until the Council has reviewed and adopted revised standards for neighborhood parks, and

WHEREAS, park standards have yet to be approved by the Council and the Council wishes to continue the moratorium pending such review and approval; NOW, THEREFORE,

BE IT RESOLVED, by the Council that the City Manager is hereby directed to continue in effect a moratorium on neighborhood park site acquisition pending review and adoption of revised General Plan Park Standards.
