VACATION OF AN UNSPECIFIED RIGHT-OF-WAY  
IN SECTION 29, T14S, R2W

WHEREAS, it is proposed that an unspecified right-of-way in Section 29, T14S, R2W be vacated; and

WHEREAS, there is no present or prospective use for the street either for the public street system for which the right-of-way was originally acquired or for any other public use of a like nature that can be anticipated in that this right-of-way is not needed for public street purposes, a bikeway or for access to open space; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation or abandonment is not inconsistent with the General Plan or an approved Community Plan; and

WHEREAS, the public street system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, California, that an unspecified right-of-way in Section 29, T14S, R2W, as more particularly referred to in Resolution of Intention No. 222164, is unnecessary for present or prospective public street purposes.

BE IT FURTHER RESOLVED, that an unspecified right-of-Way in Section 29, T14S, R2W, as more particularly shown on Exhibit A, which is by this reference incorporated herein and made a part



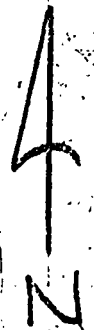
