WHEREAS, the State of California established the Roberti - Z'berg Urban Open Space and Recreation Program to fund the development of urban parks; and

WHEREAS, the Roberti - Z'berg Urban Open Space and Recreation Program has provided The City of San Diego grant funding since fiscal year 1978; and


WHEREAS, these grant funds and matching City funds have been used to acquire neighborhood park sites and develop a portion of Balboa Park; and

WHEREAS, the State Department of Finance is not recommending that Governor Brown include \$25 million for the funding of the Roberti - Z'berg Urban Open Space and Recreation Program in the State's 1979-80 budget; and

WHEREAS, in fiscal years 1979 and 1980, the City's share of these grant funds are programmed to acquire and develop "Vest Pocket Parks" of 1-3 acres in the City of San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that the Council hereby strongly urges Governor Brown and the State Legislature to include \$25 million in the 1979-80 State budget for the Roberti - Z'berg Urban Open Space and Recreation Program.
