1. That the bid of \$92,950.00 by DALEY CORPORATION, a corporation for the REPLACEMENT OF EL CAMINO REAL BRIDGE OVER GONZALES CANYON CREEK (STORM DAMAGE REPAIR) in the City of San Diego, California, is hereby accepted; and that the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 764903.
2. That the expenditure of \$116,470.00 is hereby authorized out of the Disaster Assistance Fund 39024 of the City of San Diego solely and exclusively for providing funds for said project and related costs.
3. That the City Auditor and Comptroller is hereby authorized to add CIP No. 53-029 (REPLACEMENT OF EL CAMINO REAL BRIDGE OVER GONZALES CANYON CREEK (STORM DAMAGE REPAIR) to the FY 1979 Capital Improvements Program.
