

RESOLUTION No. 222427 (R-79-1019)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the petition for the improvement of SORRENTO VALLEY ROAD PHASE II, under the provisions of the Improvement Act of 1911, consisting of four sheets and filed under Document No. 765222, is hereby granted.

BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby directed to prepare plans, drawings, typical cross-sections, profiles and specifications for the improvement of SORRENTO VALLEY ROAD PHASE II in the City of San Diego, by the construction of watermains in Sorrento Valley Road from the northeasterly line of Parcel 5 of Acre Lot 8, Sorrento Lands and Townsite westerly to the southerly prolongation of the westerly lot line of Parcel 1 of Parcel Map 6227, together with estimates of the costs and expenses of such work and to furnish this Council with a description of the district to be included in the assessment for the work and improvements hereinabove mentioned.
