BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of those street easement deeds of DONALD J. KEITH and SHARON F. KEITH, and DONALD J. KEITH and WILLIAM JOSEPH KEITH, executed in favor of The City of San Diego, bearing dates of October 4, 1978 and October 4, 1978, conveying to said City the permanent easement and right-of-way for a public street and incidents thereto, over, under, upon, along and across all that portion of Lots 5, 6, 9 and 10, Block 439 of G. C. Arnold's Subdivision of the East half and South Quarter of the West half of Pueblo Lot 1122, Map No. 381 and Lots 3, 4, 7 and 8, Block 439 of G. C. Arnold's Subdivision of the East half and South Quarter of the West half of Pueblo Lot 1122, Map No. 381 respectively, as more particularly described in said deeds, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named GLENWOOD DRIVE.

That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution attested by him under seal, to be recorded in the office of the San Diego County Recorder.
