

RESOLUTION No. 222430 (R- 79-1033)

Adopted on DEC 18 1978

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of BEATRICE R. CORREIA and FRANK T. CORREIA, executed in favor of The City of San Diego, bearing date of September 26, 1978, conveying to said City the permanent easement and right of way for a public street, and incidents thereto, over, under, upon, along and across all that portion of Block 162, La Playa, being also a portion of Qualtrough Street vacated June 6, 1956 by Resolution No. 133441, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named QUALTROUGH STREET.

That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Engineering and Development Department for further handling.
