

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a First Amendment to Agreement with LERCH, BATES & ASSOCIATES, INC. in connection with the design of certain seismic restraints to provide earthquake protection for all City-owned and operated passenger and freight elevators as required by California State Occupational Safety and Health Standards, under the terms and conditions set forth in the First Amendment to Agreement on file in the office of the City Clerk as Document No. 765247.

BE IT FURTHER RESOLVED, that the expenditure of \$37,750 is hereby authorized from Fiscal Year 1979 Capital Outlay Fund 245, solely and exclusively for the purpose of providing funds for said services.
