WHEREAS, the successful implementation of the Marina/  
Columbia Residential Project requires Block Grant funds in the  
estimated amount of \$12,500,000; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego  
as follows:

(1) That the work program and budget for the Marina/  
Columbia Residential Project as set forth in the document on  
file in the office of the City Clerk as Document No. 765272  
be and the same are hereby approved;

(2) That the City Auditor is hereby authorized for the  
purpose of implementing the Marina/Columbia Residential Project  
to transfer the sum of \$900,000 from Community Development Block  
Grant Fund No. 2940 to Redevelopment Agency as an advance to be  
repaid from tax increment or other project revenues. In the  
event that the Agency desires to issue bonds, notes, or other  
instruments of indebtedness of the Agency to carry out the  
Marina or Columbia Redevelopment Project, then the indebtedness  
of the Agency under this resolution shall be deemed not to be a  
first pledge of tax increment allocations received by the Agency  
pursuant to Health and Safety Code, Section 33670; and the indebted-  
ness of the Agency under this resolution shall be subordinate  
to any pledge of tax increments to bondholders or the holders of  
other such instruments of indebtedness.




