BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to accept an offer from Jeffries Bank Note Company for the printing of an official statement, a supplemental selling brochure, a notice of sale inviting bids and such other underwriting documents as are customarily given wide circulation within the financial community for the first series of San Diego Open Space Park Bonds of 1978, under the terms and conditions set forth in that letter agreement on file in the office of the City Clerk as Document No. 765348.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$15,200 from Environmental Growth Fund No. 2505 is hereby authorized for said services.

BE IT FURTHER RESOLVED, that the City Manager, in consultation with the City's financial consultant, is hereby authorized and empowered to incur expenses in an additional amount of not to exceed \$4,000 from said Environmental Growth Fund No. 2505 for miscellaneous costs which may be incurred in connection with the marketing of said bonds.
