BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the City Auditor and Comptroller is hereby authorized to add CIP 52-266 (Hillside Drive and Via Capri - Construction of Improvements) to the FY 1979 Capital Improvements Program.
2. That the City Auditor and Comptroller is hereby authorized to transfer \$270,000.00 from CIP 22-031 (Sail Bay Development) Capital Outlay Funds to CIP 52-266.
3. That the bid of \$253,253.00 by EL CAJON GRADING & ENGINEERING CO., INC., a corporation for the CONSTRUCTION OF IMPROVEMENTS ON HILLSIDE DR., BETWEEN VIA CAPRI AND RUE ADRIANE, AND IN VIA CAPRI BETWEEN HILLSIDE DR. AND RUE MICHAEL IN LA JOLLA, CALIFORNIA (STORM DAMAGE REPAIR), Base Bid, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 764589.
4. That the expenditures of \$270,000.00 from Capital Outlay Fund (CIP 52-266), \$34,393.00 from Disaster Assistance Fund 39024 and \$24,507.00 from Sewer Revenue Fund 506 Annual Allocation, of the City of San Diego are hereby authorized solely and exclusively for providing funds for said project and related costs.
