WHEREAS, The City of San Diego is the owner of a fee interest in that portion of Quarter Section 63 of Rancho de la Nacion, in the City of Chula Vista; and

- 4. That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Department for further handling.
