AN ORDINANCE INCORPORATING LOT 1, BERNARDO INDUSTRIAL PARK UNIT NO. 1, MAP 5864; LOT 2, BERNARDO INDUSTRIAL PARK UNIT NO. 2, MAP 6007; LOT 3, BERNARDO INDUSTRIAL PARK UNIT NO. 3, MAP 6035; LOT 5, BERNARDO INDUSTRIAL PARK UNIT NO. 3, MAP 6035; LOT 6, BERNARDO INDUSTRIAL PARK UNIT-NO. 4, MAP 6093; LOT 8, BERNARDO INDUSTRIAL PARK UNIT NO. 5, MAP 6617; LOT 9, BERNARDO INDUSTRIAL PARK UNIT NO. 6, MAP 6275; LOT 11, BERNARDO INDUSTRIAL PARK UNIT NO. 8, MAP 6293; LOT 12, BERNARDO INDUSTRIAL PARK UNIT NO. 9. MAP 6513; AND PARCELS A AND B. PARCEL MAP NO. 1010, (APPROXIMATELY 221.52 ACRES), LOCATED WEST OF I-15 BETWEEN BERNARDO CENTER DRIVE AND RANCHO BERNARDO ROAD, IN THE RANCHO BERNARDO COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO M-IP ZONE, AS DEFINED BY SECTION 101.0435.1 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 9576 (NEW SERIES), ADOPTED JANUARY 19, 1967, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

That Lot 1, Bernardo Industrial Park Unit Section 1. No. 1, Map 5864; Lot 2, Benrado Industrial Park Unit No. 2, Map 6007; Lot 3, Bernardo Industrial Park Unit No. 3, Map 6035; Lot 5, Bernardo Industrial Park Unit No. 3, Map 6035; Lot 6, Bernardo Industrial Park Unit No. 4, Map 6093; Lot 8, Bernardo Industrial Park Unit No. 5, Map 6617; Lot 9, Bernardo Industrial Park Unit No. 6, Map 6275; Lot 11, Bernardo Industrial Park Unit No. 8, Map 6293; Lot 12, Bernardo Industrial Park Unit No. 9, Map 6513; and Parcels A and B, Parcel Map No. 1010, (approximately 221.52 acres), located west of I-15 between Bernardo Center Drive and Rancho Bernardo Road, in the Rancho Bernardo Community Plan Area, in the City of San Diego, California, within the boundary of the district designated "M-IP" on Zone Map Drawing No. C-640, be, and it is hereby incorporated into M-IP Zone, as such zone is described and defined by Section 101.0435.1 of the San Diego Municipal Code.

Section 2. That Ordinance No. 9576 (New Series) adopted January 19, 1967, of the ordinances of the City of San Diego be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
