AN ORDINANCE AMENDING CHAPTER V, ARTICLE 3,
OF THE SAN DIEGO MUNICIPAL CODE BY ADDING
SECTION 53.30 REGULATING DANGEROUS WEAPONS
USED DURING PICKETING, DEMONSTRATIONS AND
STRIKES.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That Chapter V, Article 3, of the San Diego
Municipal Code be and the same is hereby amended by adding
Section 53.30 to read as follows:


SEC. 53.30 DANGEROUS WEAPONS USED DURING PICKETING,
DEMONSTRATIONS AND STRIKES

No person shall carry or possess while parti-
cipating in any demonstration, rally, picket line
or public assembly any metal stake, club, or pipe,
or any length of lumber, wood, or lath, unless
that wooden object is 1/4" or less in thickness,
and 2" or less in width. If not generally rectan-
gular in shape, such wooden object shall not exceed
1/2" in its thickest dimension.

Section 2. This ordinance shall take effect and be in
force on the thirtieth day from and after its passage.


