AN ORDINANCE AMENDING SECTION 61.2004 OF
THE SAN DIEGO MUNICIPAL CODE RELATING TO
THE SAN DIEGO PARK FACILITIES DISTRICT
PROCEDURAL ORDINANCE

BE IT ORDAINED, by the Council of the City of San Diego, as follows:


Section 1. Section 61.2004 of the Code cited in the title is amended to read as follows:

SEC. 61.2004 Procedure.

Excepting for matters therein inconsistent with the provisions of this Division, the provisions of the Community Facilities Law of 1911 (Chapter 1 [commencing with Section 4601], Part 3, Division 5, Health and Safety Code), excepting Article 2a, Section 4623 and the last sentence of Section 4638 thereof, shall apply to the formation and government of such districts.

Section 2. This ordinance shall be published once in the official City newspaper within ten days and shall take effect thirty days from and after its passage.
