

AN ORDINANCE INCORPORATING THE OTAY RIVER FLOODPLAIN GENERALLY BOUNDED BY THE CITY OF IMPERIAL BEACH AND THE RIGHT-OF-WAY OF THE SAN DIEGO AND ARIZONA EASTERN RAILROAD ON THE WEST, BY THE CITY OF CHULA VISTA AND UNINCORPORATED AREAS OF SAN DIEGO COUNTY ON THE EAST, AND BY PALM AVENUE AND ELM AVENUE ON THE SOUTH, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO FW ZONE, AS DEFINED BY SECTION 101.0403 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING CERTAIN ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the Otay River Floodplain generally bounded by the City of Imperial Beach and the right-of-way of the San Diego and Arizona Eastern Railroad on the west, by the City of Chula Vista and unincorporated areas of San Diego County on the east, and by Palm Avenue and Elm Avenue on the south, in the City of San Diego, California, within the boundary of the district designated "FW" on Zone Map Drawing No. C-629.1, be, and it is hereby incorporated into FW Zone, as such zone is described and defined by Section 101.0403 of the San Diego Municipal Code.


Section 2. That the following ordinances of The City of San Diego, be, and the same are hereby repealed insofar as they conflict herewith:

This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
