AN ORDINANCE INCORPORATING LOTS 1 AND 2, AND A PORTION OF LOT 3, BLOCK 45, GRANTVILLE AND OUTLOTS, MAP NO. 776 AND A PORTION OF TWAIN AVENUE CLOSED, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO M-1A ZONE, AS DEFINED BY SECTION 101.0436 OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that within two years of the effective date of this ordinance Lots 1 and 2, and a portion of Lot 3, Block 45, Grantville and Cutlots, Map No. 776 and a portion of Twain Avenue Closed, in the City of San Diego, California, designated "M-1A" on Zone Map Drawing No. B-3169, is subdivided and a map or maps thereof duly submitted to the City and thereafter recorded, and within such subdivision or subdivisions provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of Section 101.0436 shall attach and become applicable to the said subdivided land, and the said subdivided land shall be incorporated into M-lA Zone, as described and defined by Section 101.0436, the boundary of such zone to be as indicated on Zone Map Drawing No. B-3169, filed in the office of the City Clerk as Document No. 765256. Said zoning shall attach only to those areas included in the map as provided in this section.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no

building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
